Reorganization

Mayor Sanford called for nominations for the Office of President of Council. Councilman Noll nominated Samuel Snyder for the Office of President of Council. No other nominations. All in favor. Councilman Snyder abstained.

Mayor Sanford called for nominations for the Office of Vice President of Council. Councilman Harper nominated Seth Noll. No other nominations. All in favor. Councilman Noll abstained.

Solicitor's Report Continued

Republic Services proposed a trash day change to Tuesday. Councilman Snyder said that the garbage contract was bid for Friday pick up, and this may be unfair to a competitor to change the day. Would the garbage bid have to be re-opened? Discussion continued. Councilman Snyder asked if anyone wanted to move the collection day from Friday to Tuesday with the current contract with Republic. Does anyone want to make that motion? The option of collection day changes dies due to lack of a motion. Diana will notify Andy Warntz of the decision.
